

## APPROVED BLOODBORNE PATHOGEN EXPOSURE CONTROL TRAINING PROVIDERS

Body art procedures, such as tattooing, body piercing, and permanent cosmetics can potentially expose bloodborne pathogens from one person to the next. To ensure the safety of the practitioner and client, all body art practitioners are required to complete an annual bloodborne pathogens exposure control training class which is specific to body art and meets the requirements of the California Health and Safety Code Section 119307 and the requirements of the California Occupational Safety and Health Administration Bloodborne Pathogen Standard contained in Section 5193 of Title 8 of the California Code of Regulations. The training and training material must be specific to performing body art and consist of not less than two (2) hours of instruction. Records of training shall be maintained for three years and available for inspection upon request of the enforcement officer.
