Publication of Notice for Modified Solid Waste Facility Permit Application

In compliance with Title 27 California Code of Regulations (27 CCR) Section 21660.3, the Environmental Health Division (Division) acting as the Local Enforcement Agency (LEA), and the applicant (operator), shall notice within 60 days of receipt of an application for modified solid waste facility permit (SWFP), and post for at least ten (10) days, a temporary public notice of the proposed modification to the SWFP.

Description of Proposed Changes

1. Transfer processing of source separated organic waste, including commercial food and commingled food and green material.
2. Update the Transfer Processing Report to address new regulatory requirements contained in SB 1383, including organics measurements.
3. Modify the Transfer Processing Report to include the Food Waste Receiving and Transferring Plan (Attachment T) which describes the separation of food waste, including post-consumer food waste, from commingled organic waste.

4. Update cross referenced sections and the conformance finding on page 1 of the SWFP.

LEA Findings

The Division's preliminary determination is the proposed changes require modification of the SWFP with the following findings:

1. The proposed changes are consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents for Del Norte;
2. The proposed changes are acceptable and consistent with, but not limited to, State minimum standards in 14 CCR;
3. The proposed changes do not conflict with the terms and conditions in the current SWFP;
4. The proposed changes to update cross referenced sections and the conformance finding on page 1 of the SWFP are non-material changes as specified in 27 CCR Section 21563(d)(5).
