In compliance with Title 27, California Code of Regulations, Section 21660.4(b), the Ventura County Environmental Health Division acting as the Local Enforcement Agency (LEA) participated in a Ventura County Board of Supervisors (Hearing) held by the Ventura County Planning Division on January 26, 2021, and continued on March 16, 2021. The Hearing was for the approval of a Modification to Conditional Use Permit 3141 (CUP 3141), Case No. PL17-0121, in conjunction with TRL's application package for revision of the Solid Waste Facility Permit (SWFP). The application for a revised SWFP was accepted as complete for filing by the LEA on January 29, 2021.

Description of the SWFP Revision:

TRL proposes a change in permit limits to increase the accepted daily tonnage based on 152 heavy truck trips per day. The current permit limit of 1,500 tons per day (TPD) will be changed to a maximum of 2,864 TPD (equivalent to 152 heavy trucks per day). Based on anticipated customer disposal needs, TRL projects the future daily waste receipts to average 1,900 TPD. This is over 6 operating days per week and approximately 306 operating days per year which equates to a projected annual waste flow of 581,400 tons per year. There will be no change to the maximum traffic volume per day (VPD) which will remain at 210 VPD. TRL also proposes to change the current 2027 closure date to April 2033. The new projected closure date is based on historical data calculated using the most recent topographic map of the landfill from June 11, 2020. The SWFP revision also includes removal of the 15-million-ton lifetime cap, updates to cost estimates, and modifications to the CUP conditions of approval. The LEA determined that the above proposed changes were significant thus requiring a revised SWFP.

Purpose of the Meeting

The Hearing held on January 26, 2021, and continued on March 16, 2021, was for any interested parties to learn more about the proposed modification to the CUP and proposed revision of the SWFP, and to provide comments to the LEA. The meeting was strictly informational with no official decision made at the meeting regarding the SWFP application. A formal determination must be made by the LEA and concurrence by California Department of Resources Recycling and Recovery (CalRecycle) within 120 days of permit completeness.
