**INSTRUCTIONS AND FEE SCHEDULE FOR
COMMUNITY EVENT ORGANIZER APPLICATION**
THIS IS A REFERENCE DOCUMENT. DO NOT SUBMIT.

This is only for community events where food is being distributed to the public.

1. The Community Event Organizer must complete the Community Event Organizer Application. This application, along with ALL the Temporary Food Facility (TFF) applications and fees must be submitted to the Environmental Health Division (EHD) at least 30 days before the event.
2. The applications are available on our website or at the EHD public services counter.
3. The Community Event Organizer must submit the following:
 - a. Community Event Organizer Application and fee (see page 2)
 - b. TFF Operator Applications and fees
 - c. Detailed Site Plan (*see sample on page 3*) drawn to scale that includes the following:
 - Location of all Temporary Food Facilities (TFFs), Mobile Food Facilities (MFFs), and Ventura County Cottage Food Operations.
 - Location and number of all toilet and handwashing facilities.
 - Location and number of 3-compartment warewashing sinks.
 - Location of potable water source (be specific).
 - Location of any animal areas.
 - Location of all trash disposal containers.

Definitions:

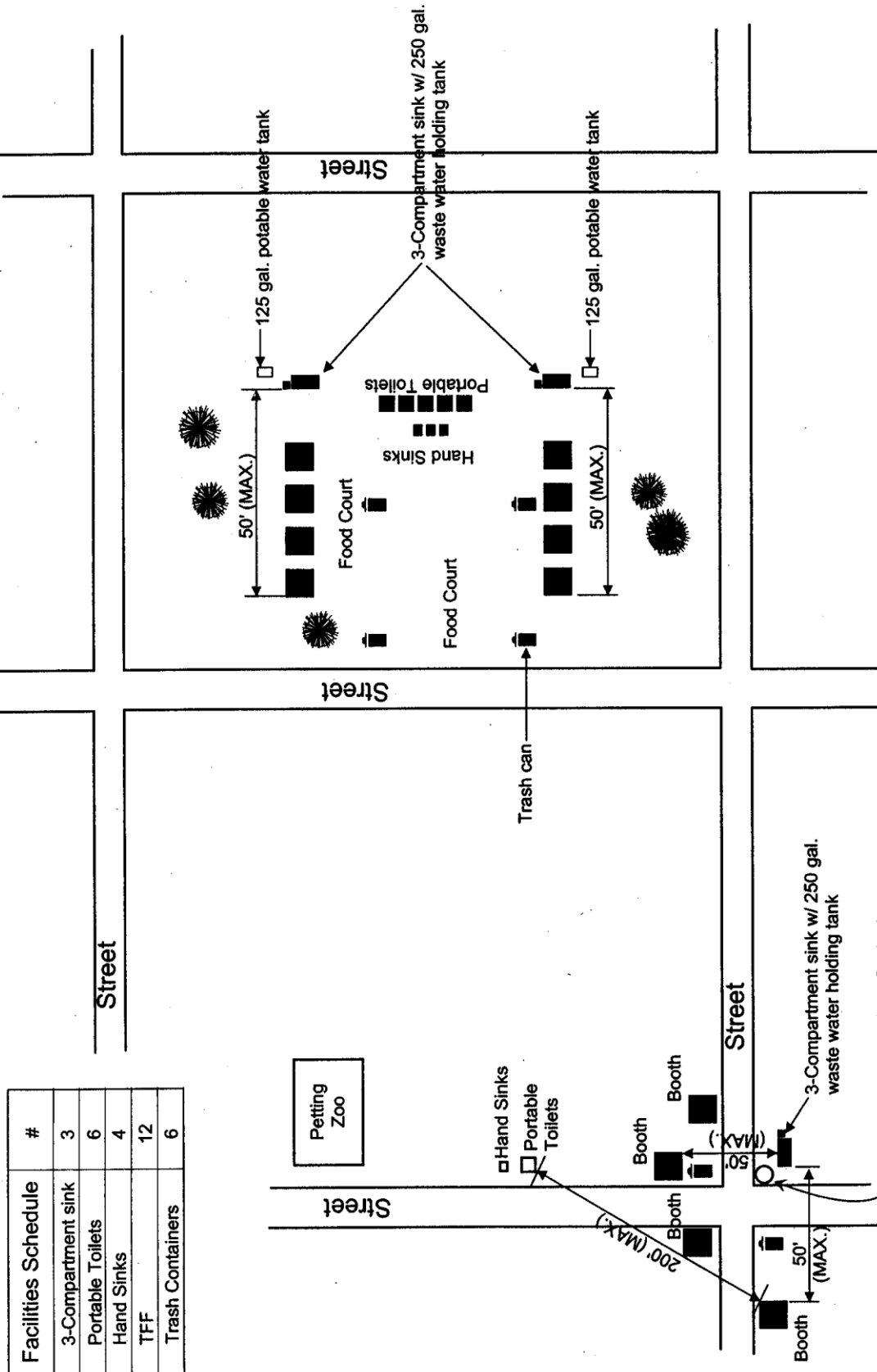
TFF-1: Handles unpackaged and/or potentially hazardous foods as defined in Health and Safety Code Section 113871.

TFF-2: Handles only prepackaged, non-potentially hazardous foods.

3. At a Certified Farmers' Market, 1-5 TFF-1 and any number TFF-2	\$626.00
4. At a Certified Farmers' Market, 6 or more TFF-1 and any number TFF-2	\$787.00
5. Full Fee Waiver	—
Requirements to qualify for a full fee waiver: a. The event is sponsored by a non-profit charitable organization. b. A member providing food safety oversight possesses a valid Temporary Food Facility / Community Event Certificate of Training issued by EHD and this member will be available at the event. c. This application was received at least 30 days prior to the event. <i>Provide a copy of TFF training certificate and documentation of non-profit charitable status. Complete the Certification on the first page of the Community Event Organizer Application.</i>
