Bloodborne Pathogen Exposure Control Training Classes

Body art procedures, such as tattooing, branding, body piercing, and permanent cosmetics can potentially provide an exposure to bloodborne pathogens from one person to the next. To ensure the safety of the practitioner and client, proper safety precautions and procedures should be followed within the body art facility. Body art practitioners, contractors, volunteers, and employees that could possibly have a bloodborne pathogen exposure are required to complete a bloodborne pathogen training class that meets the requirements of the California Occupational Safety and Health Administration Bloodborne Pathogen Standard contained in section 5193 of Title 8 of the California Code of Regulations. The training and training material must be specific to performing body art and shall consist of not less than two hours of instruction. Records of training shall be maintained for three years and shall be available for inspection upon request of the enforcement officer.
