#### 7. COMMENTS FROM PLANNING STAFF

Dillan Murray, staff, reported that Jill Martinez has retired from the Rent Review Board after three years of volunteer service. Mr. Murray thanked her for her time and energy and noted that staff looks forward to the Board of Supervisors making an appointment in the coming future.

Next, Mr. Murray reported that the Planning Division has approved 15 ministerial rent increase applications for 2024. The Cost-of-Living Adjustment (COLA) for 2025 will be released by the Social Security Administration in October.

Finally, Mr. Murray reported that the Planning Division is currently working to update the guidelines for discretionary rent increase applications, last adopted in 1997. As a reminder, park owners may apply for a discretionary rent increase in cases where the facts and circumstances show that the current park rent income is less than when the park was purchased, and these are reviewed and determined by the Rent Review Board in a public hearing. In general, the guidelines will be updated to correct typographical errors and to provide needed clarification on review procedures. The proposed revisions will be brought forward to the Rent Review Board at the November quarterly meeting.

The next hearing of the RRB is planned to be held Wednesday, November 13, 2024, at 1:00 p.m. At 1:12 p.m., the RRB was adjourned.
